# 1. Who are we?

- ▶ NBB-SSS = NCB-CSD
- ▶ Since 1991
- ▶ Belgian fixed income
  - state (2/3)
  - non-state (1/3)
- ▶ Outstanding amount issued (€ 530 bn)
- ▶ Number of transactions (2011: 600 000)



## 2. The new software (1)

- ▶ Existing software: built in 1991
- ▶ Options:
  - In-house:
    - expensive to build
    - maintenance: future T2S-adaptations/releases be paid by 1 party
  - Software company:
    - too much time and input from our side




## 2. The new software (2)

- External solution: RfP (March 2011)
  - existing CSD, or
  - software already used by other CSDs
- Final choice: Montran Software
  - = runs on NBB's preferred IT-architecture
  - HW: Sun-solaris
  - DB: Oracle
  - Web interface: without local apps



### 3. The 2 phase approach: What?

- ▶ Phase 1: New software in Q4.2014 (01-12-2014)
- ▶ Phase 2: T2S Connection in Q1.2016




# 3. The 2 phase approach: Purpose

- ▶ Reduction of operational risk
- ▶ Independent from
  - The timing of T2S
  - The migration wave (*except wave 1*)
- ▶ Many new T2S features will be available in 2014:
  - New state-of-the-art features
  - Maximum compliance with the latest market standards
  - Our participants
    - will be > 80 % T2S-compliant
    - can rationalize tools, interfaces and procedures ahead of T2S
  - Reduction of the Giovannini barriers

- ▶ New T2S compliant features for NBB-SSS
- ▶ Features remaining NBB-SSS specific
- ▶ Features abandoned



# 4.1 Phase 1: New T2S compliant features

- BIC11-codes to identify NBB-SSS participants
- T2S Securities Account Number structure
- T2S matching rules
- Prioritisation
- Partial settlement
- Linked instructions
- Hold and release
- T2S recycling rules
- Market claims & transformations
- New STP messages (ISO 20022)



## 4.2 Phase 1: NBB-SSS Specific features

- X/N system
- Automatic lending
- New NBB-SSS GUI
- Repo
  - Optional service
  - **NEW**: Same Day Repo



## 4.3 Phase 1: Abandoned features

- Settlement Cycles
- Sending number
- Unilateral cancellation
- Account segregation for foreign currency assets
- NBB Notification types → ISO instruction types
- Reservations




## 5. Phase 2

- ▶ Important new T2S functions:
  - Direct communication with T2S: ISO 20022
  - Night-time settlement
  - Automated cross-border settlement
    - activation of links between CSD's
  - Auto-collateralisation
  - Cash settlement via T2S Dedicated Cash Accounts (DCAs), no more DLNS
  - Conditional settlement (CoSD)
