Daily volume Increase

- January to February: 15,92 %
- February to March: 3,98 %

Traffic breakdown by category

Breakdown per value band



- Breakdown per value band **extremely** stable despite traffic growth
- The average value of instant payments settled in TIPS is stable at around 600 €
- More then 88% of TIPS instant payments are **below 1,000 €**
- Daily average turnover in TIPS is **1.4 bn €** (March 2025)

Overall liquidity in TIPS

- In March 2025, the average liquidity left overnight in TIPS stood at €29.3 bn (+34.5% vs March 2024)
- Recent increase mainly visible on TIPS DCAs
- Liquidity per account type (March 2025)
 - TIPS DCAs 63%
 - TIPS ASTAs 37% 💳

Overall liquidity in TIPS





- Participants do reduce their liquidity buffers on TIPS accounts during the end-of-day / start of day phase
- No significant differences between weekdays and weekends
- Two changes recently observed:
 - Higher magnitude of adjustments (from 6 to almost 10 bn€)
 - The reduction of the buffers is taking place earlier in the day

INC431762	05/03/2025	Malfunction in a high-speed fiber-optic cabling that serves one of the TIPS data centers	when incident occurred, no settlement took place	57 min
