target TIPS R2025 – Overview of candidate CRs

Currently, the only CR officially allocated to the TIPS R2025.NOV is the TIPS-0028, while the TIPS-0064 (which turned out to be unfeasible in TIPS R2024.NOV) should now be candidate for a release from 2025 onwards.

However, following the recent EPC announcement of the revised entry-into-force dates for the 2025 Rulebooks, now set for 5 October 2025, it will be necessary to make some reasoning to decide how to handle the TIPS 2025 major release, currently scheduled, as usual, in November.

It is worth to remind that, in any case, their possible allocation to a TIPS future release will have to be confirmed, as usual, by a Feasibility Assessment exercise.
