Description of requested change:

The 2019 SCT Inst rulebook version 1.0 enters into force on 17 November 2019 and is applicable until November 2021. Together with the version 1.0 of the 2019 SEPA SCT Inst rulebook, the EPC delivered the Implementation Guidelines (IGs) which set out the SEPA rules for implementing the C2B and the interbank ISO 20022 XML message standards. All the changes compared to the previous version 1.0 (2017) have been reflected in the TIPS Specifications documents and User Requirements document by means of change request TIPS-0012-URD in the scope of the TIPS Release 2.0. Over the course of 2019, an errata document was published by the EPC which contains minor updates to the above IGs. The "Errata" will become effective as from 17 November 2019.

The proposed change request aims at aligning TIPS specifications to the ERRATA to the 2019 version 1.0 of the SEPA Instant Credit Transfer customer to bank (C2B) and Interbank Implementation Guidelines EPC116-19 / Version 1.0.

Reason for change and expected benefits/business motivation:

The change request for the alignment of TIPS to the "Errata" document permits TIPS to be aligned to the revised EPC SCT^{Inst} specifications.

The ERRATA document lists:

- 8 updates to the SEPA Instant Credit Transfer Interbank Implementation Guidelines (IGs):
 - o 1 Addition of an usage rule (A/001)
 - o 5 Change or further alignment with Rulebook content ((A/002-005)
 - o 2 Typing and layout errors (A/006-007)
- 1 update to the SEPA Instant Credit Transfer C2B IGs:
 - o 1 Typing and layout error (B/001)

The above updates have an impact on the current processing flows in TIPS.

2) TIPS UDFS v2.1.0 - §1.5.2.3. Investigation process. Wording alignment to include the possibility to perform investigation on multiple transactions (A/002)

In line with the SCT^{Inst} scheme rulebook, TIPS supports a transaction status investigation process, which can be initiated only by Participants or Instructing Parties acting on behalf of Participants or Reachable Parties on the originator side using the transaction status inquiry message. This allows TIPS Actors to retrieve the last generated payment transaction status advice for a single or a set of transactions contained in the status request. If no payment transaction status advice is present, an error is returned for each transaction under investigation.

3) TIPS UDFS v2.1.0 - §2.4. Investigation. Wording and processing alignment to include the possibility to perform investigation on multiple transactions (A/002).

The transaction status investigation process can be initiated by Participants or Instructing Parties acting on behalf of Participants or Reachable Parties on the originator side using the transaction status inquiry message, allowing the TIPS Actors to retrieve the last generated payment transaction status advice for each transaction referenced in the investigation request.

If the Investigation message is correctly received, for each of the transaction referenced in the investigation request, if and the requested transaction is existing and still *Reserved* (meaning that no Beneficiary side confirmation/rejection has been received and no sweeping has been performed), then TIPS assumes that the Instant Payment is timed-out. In this case, TIPS does not answer to the Investigation directly, but set to *Expired* the Instant Payment transaction, informing both Originator and Beneficiary side accordingly (see 2.2.1 “Timeout scenario: missing/delayed Beneficiary-side answer”).

The FI to FI Payment Status Request message allows instructing TIPS for retrieving the status of an single or group of Instant Payment transaction.

This message covers the scenario of (i) Status investigation message and (ii) Request for Status Update on a Recall:

- The Originator Bank or Instructing Party can start the investigation process on an single or group of previously instructed Instant Payment Transactions;
- The Originator Bank or Instructing Party can start the Request for Status Update on a single or group of Recalls previously instructed.

5) TIPS UDFS v2.1.0 - §2.3 Recall: wording alignment to support investigation on multiple recall (A/004 and A/005)

- If no response to a previously sent FIToFIPaymentCancellationRequest is received, the Recall Assigner can send a FIToFIPaymentStatusRequest message to TIPS to request a ~~'Recall'~~ status update on a single Recall or on a set of Recall referred to the same Recall Assignee. The message, after successful validation, is forwarded by TIPS to the Beneficiary Participant (i.e. the Recall Assignee) for further processing. The answer to such message generated by the Recall Assignee is either a PaymentReturn (positive response) or a ResolutionOfInvestigation (negative response) for each Recall referenced in the FIToFIPaymentStatusRequest message.
