Reason for change and expected benefits/business motivation:

It was observed that different stakeholders/TIPS have a varying interpretation of the EPC SCTInst Implementation Guidelines (IGs) with respect to the use of some optional fields. For this reason, TIPS and TIPS participants asked EPC for clarification on the expected handling of these optional fields. The fields in question are Ultimate Debtor, Debtor, Creditor and Ultimate Creditor in camt.056, camt.029, pacs.004 and pacs.028 messages (the level of detail is not present in the IGs compared to the description of the usage of these fields in the pacs.008). Applying the ISO20022 customisation used by all the TARGET Services, TIPS removed these fields, since (i) not explicitly required by the EPC (no SEPA CORE or white shading fields) and (ii) not used in TIPS.

In this regard, the EPC clarified that the below usage rules (as usually included in element ‘Original Transaction Reference’ – but there are exceptions) are to be interpreted as follows (related to a camt.056 as an example):

- “An exact copy of all attributes of the initially sent DS-02 which is to be cancelled”: This means all the information received in the original pacs.008 needs to be copied under ‘Original Transaction Reference’ (subject to availability) by populating the same (sub)elements as used in the original message. In some cases, however, only a very limited number of sub-elements is to be provided in order to create a ‘leaner’ message. For example, in the pacs.028 used as transaction status investigation message, only sub-elements ‘Payment Type Information’ and ‘Debtor Agent’ are to be provided.
- “The message elements under ‘Original Transaction Reference’ must be populated with the same value as the message elements of the original instruction” (whilst taking into account the previous usage rule as well as the above ISO definition): This means that if for example, an LEI is given for element ‘Ultimate Debtor/Identification/ Organisation Identification/LEI’ in the pacs.008, the same LEI is to be put under ‘Original Transaction Reference/Ultimate Debtor/ Party/Identification/ Organisation Identification/LEI’ of the camt.056.

For this reason, an alignment of TIPS based on the EPC clarifications on IGs is deemed necessary.

Following the same rationale, a similar requirement, limited to camt.056 and camt.029, has been raised in the context of non-euro scheme.

Description of requested changes:

According to the rationale described above, the below TIPS messages and fields shall be aligned to the actual implementation of both the EPC IGs and NPC IGs respectively.

<p>In order to enable customers to specify the OrgID tag (unique and unambiguous way to identify an organization) in multiple ways, the OrgID tag contained in the Ultimate Creditor, Creditor, Debtor and Ultimate Creditor non-leaf nodes has been harmonized for: FIToFIPaymentCancellationRequest (camt.056), PaymentReturn (pacs.004), ResolutionOfInvestigation (camt.029), FIToFIPaymentStatusRequest (pacs.028), non-Euro FIToFIPaymentCancellationRequest (camt.056) and non-Euro ResolutionOfInvestigation (camt.029). For each one of this messages, customer can now choose between the BIC of the organization, the Legal Entity Identifier or a unique identification (using an identification scheme) as it can be done in the original pacs.008 or non-Euro pacs.008 and then referenced in the abovementioned messages inside the Original Transaction Reference, when applicable. All those new fields are optional in TIPS and only subject to schema validation i.e. TIPS is not using them for internal processing and will not check the values contained inside those tags apart from applying schema validation against the proper XSD.</p>
