Reason for change and expected benefits/business motivation:

Following some investigations on the configuration of the TIPS Reachable Party and ensuing implications for the TIPS Directory, the TIPS-Working Group members agreed¹ on removing the TIPS participation type column (TYPE PART) from the TIPS Directory.

One of the main arguments for this removal is that this piece of information is not relevant for the settlement purposes: the essential information for TIPS actors is whether a BIC is reachable in TIPS or not, whereas the type of participation is not used in a business perspective.
